

### SCMDA mission/purpose

Over the past two decades, government and private insurance companies have taken **aggressive and detrimental actions** towards the Dentistry profession. Their efforts and actions have led to limiting dental professionals from providing the best and most cost-efficient services for their patients. Most medical professionals covering all fields understand the importance of dental hygiene and how it can significantly impact a person's overall health.

In contrast, the government at both the federal and state levels has followed **private insurance companies' profits** and has become **increasingly hostile** towards dentistry. As a result, unlike other medical disciplines, the government and private insurance companies treat dental services for patients in need as more of an elective and not a necessity.

Through **overburdening regulations and policies,** they make decisions that trump dental professionals' medical advice. The **intrusion of government** and private insurance results in dental professionals forced to offer **only unnecessary and invasive procedures,** which are often more expensive than their family dentist's advice.

In rural and economically disadvantaged communities, government and private insurance intervention in the field ultimately **leads to patients being denied care** or being **priced-out of treatment** options, and far too many times downgraded to less effective alternatives.

Furthermore, government and private insurance companies continue to **place unfair and overbearing regulations** that directly impact dentistry as a local and community small-business. This **unfair financial treatment** increases the possibility of local and community dentist offices closures.

### SCMDA priority legislation **H. 4588**

Filed by Rep. Deon Tedder (District 109 - Charleston)

TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 38-71-235 SO AS TO PROHIBIT THE INCLUSION OF ALTERNATIVE BENEFIT CLAUSES IN DENTAL POLICIES ISSUED IN THIS STATE.

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1.** Article 1, Chapter 71, Title 38 of the 1976 Code is amended by adding:

"Section 38-71-235. (A) For purposes of this section, an 'alternate benefit clause' is a provision in a dental policy which provides that when a less expensive dental procedure that serves the same function is available, the insurer only will provide coverage for the less expensive procedure, despite the recommendation of a different procedure by the dentist. Any difference in cost between the less expensive dental procedure and the dental procedure recommended by the dentist must be paid for by the subscriber.

(B) Any dental plan issued to subscribers in this State may not include an alternate benefit clause."

**SECTION 2.**This act applies to contracts entered into, amended, extended, or renewed after June 30, 2022.

**SECTION 3.** This act takes effect upon approval by the Governor.

#### H. 4589

Filed by Rep. Deon Tedder (District 109 - Charleston)

TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 38-71-236 SO AS TO PROHIBIT THE EXCLUSION OF PREEXISTING CONDITIONS IN DENTAL POLICIES ISSUED IN THIS STATE.

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1.** Article 1, Chapter 71, Title 38 of the 1976 Code is amended by adding:

"Section 38-71-236. A dental plan issued in this State may not deny a benefit for covered dental services to treat conditions existing prior to the date the coverage begins."

**SECTION 2.** This act applies to contracts entered into, amended, extended, or renewed after June 30, 2022.

**SECTION 3.** This act takes effect upon approval by the Governor.
